## Trumbull Championed Anti Slavery Legislation *by Reverend David Crowley*

## Rotary Programs



While Lovejoy is rightly lionized as a martyr here, we lose sight of the accomplishments of Lyman Trumbull, who lived in Alton for about 20 years. (He paid \$2500 for the house, property and an orchard), and the house is on the corner of Union and Henry). Born in Connecticut of a well-known, large family of the Revolution on one side and the Puritan Mathers on his mother's side, Trumbull went to Georgia and studied law. He soon came to practice in Belleville and entered Illinois politics. He was a state representative, and secretary of state and appointed to the Illinois supreme Court. He moved to Alton as they lost a child to water-borne ailments and he heard the water was better here and that there were more folks from the East in the area.

He knew Lincoln from circuit practice of law as well as in Springfield. Trumbull fought slavery in the courts and he argued a case based on the northwest ordinance and its obstacle to slavery's expansion, lost on appeal, but triumphed later. As a judge, he twice helped with a ruling to make it difficult to impose the Fugitive Slave Act in Illinois. His wife Julia was friends with Mary Todd, but Mary broke with her hoping that she could have persuaded Trumbull to push the state senate into supporting Lincoln for the U.S. Senate.

As a Senator, Trumbull switched to the Republican party. When the Civil War broke out, he was one of the first national politicians to declare it a war about slavery. He was furious at the pace of the war and the army's slow use of his Confiscation Act to free captured slaves. He was concerned that the Emancipation Proclamation could be considered a war measure only. He proposed the Thirteenth Amendment in the Senate, using the language that became adopted from the Northwest Ordinance and led the difficult fight for its passage. Later, when teaching law in Chicago, he would say to his students, "this good right arm wrote the 13th Amendment." Crucially, he added a section for enforcement of it, to include what was termed the 'badges

and incidents" of slavery legally imposed discrimination by parties public or private. Faced with a recalcitrant South, Trumbull wrote the Civil Rights Act of 1866 to enforce rights of property ownership, making contracts, and other civil liberties. With Senator Sumner, he helped write and pass the Freedman's bureau, the largest federal social welfare program until the Great Depression that fed millions food rations, taught thousands to read, and took cases out of state courts into special courts to protect the rights of the newly freed slaves. Trumbull is still cited as the authority in Supreme Court cases when the 13th Amendment or the Civil Rights Act of 1866 is involved in an appeal.

He did not return to the Senate for another term as punishment for not voting to convict President Johnson in the impeachment trial. Before he left, he was an ardent supporter of making Yellowstone a national park and had a mountain in the area named for him. Before he left the Senate, his wife died of cancer, and only one of their children would outlive Trumbull. He would remarry and have 2 more children, but he survived them as well. Toward the end of his life, he found new support for reform politics and even went to the supreme court to argue for Eugene Debs and supported the Populist Party as he feared the growing power of corporations in his time.

What is your club’s approach to recruiting and keeping members? August, Membership and Extension Month, is an ideal time to discuss membership strategies for the year.

The Presidential Citation and Changemaker Award both include membership criteria and are excellent resources to help you set your goals. Clubs aiming for the Presidential Citation this year must add at least one new member and keep at least 85 percent of their membership. Additional goals include recruiting RI and Rotary Foundation program alumni and young professionals, and increasing diversity by adding more female members. Districts must meet similar goals. The Changemaker Award, established by RI President Kalyan Banerjee, also puts membership in the spotlight. Clubs must achieve a specific set of club service goals, including adding one new member under the age of 40 for each 50 members, implementing a comprehensive strategy for keeping members, and demonstrating that they have retained 85 percent of their members for the three Rotary years ending with 2011-12. Both recognitions also include criteria for supporting Foundation programs, crucial to Rotary’s continued global success.

Past RI Vice President Monty J. Audenart, chair of the RI Membership Development and Retention Committee, encourages all clubs to focus on their membership goals as they take a fresh look at strengthening Rotary.

“When building strong clubs, attracting new members and retaining existing ones are given first priority. Then, the rest of our service activities and programs will take care of themselves,” says Audenart.
